I waive any right to see or approve any materials in which my Likeness and/or the Content is used. I acknowledge that Red Cross shall have no obligation to use my Likeness or the Content. I agree and understand that my Likeness and/or the Content may be modified or distorted and that my own name, a fictitious name, or no name may be used in association with my Likeness and/or the Content. I agree and understand that my Likeness and/or the Content as recorded under this Release and any materials using my Likeness and/or the Content under this Release are the exclusive property of Red Cross, and I assign to Red Cross, any right, title, or interest I may have in such Content, including all copyright interests. Notwithstanding anything contained herein to the contrary, and with respect to my Likeness only, to the extent the use of my Likeness is used hereunder in a Red Cross or paid campaign in a manner that falls within and constitutes a principal performance under the SAG Commercials Contract, as an Red Cross beneficiary, I, along with the Screen Actors Guild, hereby waive all session and use fees to which I may otherwise be entitled in connection with such use for a period of one (1) year from first airdate. Subject to the preceding, I acknowledge that this Release shall fully discharge Red Cross from any and all obligations related to its use of my Likeness and/or Content.

By virtue of my voluntary submission of my Likeness and Content, and execution of this Release, I irrevocably release, discharge, and hold harmless Red Cross, its governors, officers, directors, employees, designees, subsidiaries, affiliates, licensees, successors, assigns, agents, and contractors from any and all claims, demands, or causes of action that I may now have or may hereafter have related to or arising from the capture and creation of the Content and/or use of my Likeness.
