# **Individual Volunteer Opportunity for Employees: Become a Trained Disaster Volunteer**

### **Information for Members**

#### **About the Opportunity**

When disaster strikes, the American Red Cross responds immediately—sending trained staff and volunteers to provide shelter, food, emotional support, recovery planning and other assistance to those affected.

Disasters won't stop during the coronavirus (COVID-19) pandemic—so as we head into hurricane and wildfire season this fall, our goal remains to provide anyone in need after a disaster with comfort and support. The Red Cross is proud to have a network of partners working with us as we prepare.

As part of our proactive preparedness efforts for the fall 2020 disaster season, we are reaching out to our trusted partners, including our ADGP and Disaster Responder Program members, to **ask for your help** 



building our capacity of trained disaster volunteers—specifically, shelter workers and health services workers—in order to sustain larger operations and prevent the need for people to take flights during this pandemic environment.

In the event of a disaster, for on-the-ground needs, the Red Cross will prioritize the participation of trained volunteers located within driving distance of the disaster operation. Individuals residing in states or territories that typically see hurricanes or wildfires—Florida, North Carolina, South Carolina, the Chesapeake Bay area (Virginia, Maryland, DC and Delaware), New York, New Jersey, Texas, Louisiana, Mississippi, Alabama, Georgia, California, Pacific Islands (Hawaii and Saipan) and U.S. Virgin Islands—are especially encouraged to register to become a trained volunteer.

This would be an individual (non-coordinated) opportunity for your employees to pursue on their own as interested. As a trained Red Cross volunteer, they would become part of our official volunteer pipeline and contacted directly by the Red Cross for disaster services now and in the future, depending on need.

#### **Safety Precautions**

As a humanitarian organization, the Red Cross places top priority on the health and safety of our employees, volunteers, blood donors and those who receive our aid and services. Our commitment to public health is unwavering—both during this global COVID-19 pandemic and year-round.

The coronavirus pandemic puts additional stress on families seeking shelter, which is why we have plans in place to reduce risks—such as social distancing protocols, face coverings, health screenings, prioritizing individual hotel rooms, and opening more shelters that can support fewer people than normal.

We are continuously adapting our guidance and protocols in reaction to this public health threat, while ensuring that our services endure. The safety of our workforce and the communities we serve continues to be our priority. The Red Cross follows CDC guidance, and we work closely with local health officials to safely provide help and hope when disasters strike.

#### **Volunteer Requirements**

Trained Red Cross volunteers must typically have these qualifications:

- Be at least 18 years old.
- Be in good health and able to work in stressful conditions.
- Be registered in the American Red Cross Volunteer Connection System.
- Complete minimum disaster volunteer training requirements (dependent on positions).

Additional qualifications are required for health services workers, with positions requiring professional licensure (RN and LPN/LVN) and ancillary roles available for Certified Nursing Assistants, Certified Home Health Aides, student nurses and medical students.

For this upcoming fall disaster season, we are particularly looking for volunteers that reside in (or live within driving distance from) these states or territories that typically see heightened fall disaster activity: Florida, North Carolina, South Carolina, the Chesapeake Bay area (Virginia, Maryland, DC and Delaware), New York, New Jersey, Texas, Louisiana, Mississippi, Alabama, Georgia, California, Pacific Islands (Hawaii and Saipan) and U.S. Virgin Islands.

#### **Volunteer Opportunities & Training Requirements**

Active disaster relief operations bring the Red Cross mission of alleviating human suffering in the face of emergencies to life. While it's not easy work—serving as a trained volunteer on a disaster operation can be fluid, challenging, exhausting, and unrefined—it's enormously rewarding and will provide your employees with the opportunity to make an important difference to individuals during their time of great need.

We are specifically looking for individuals willing to serve as trained **shelter workers** or **health services workers**. Both associate and supervisory level volunteer positions are available for these opportunities.

- Shelter workers support families staying in a Red Cross or partner-managed emergency shelters.
   Responsibilities may include staffing different areas including reception, registration, feeding, dormitory, information collection and other vital tasks.
- Health services workers work in emergency shelters to help assess people's health and provide
  hands-on care in alignment with their professional licensure. We also need volunteers who can provide
  care as delegated by a licensed nurse in shelters; this could include assisting with activities of daily
  living, personal assistance services, providing health education and helping to replace medications,

durable medical equipment or consumable medical supplies. Daily observation and health screening for COVID-19-like illness among shelter residents may be required.

- We have volunteer roles for individuals with RN, LPN, LVN, APRN, NP, EMT, paramedic, MD/DO and/or PA with an active, current and unencumbered license.
- Ancillary roles are available locally for Certified Nursing Assistants, Certified Home Health Aides, student nurses and medical students. RNs supervise all clinical tasks.

Below are the registration pathways and training requirements prospective volunteers would experience. This is for **NEW** volunteers only.
