- The auction is open to the public (tickets/event registration not required).
- Items available for preview on May 10, 2021; Bidding goes live at 8:00 a.m. on May 15, 2021 and concludes at 8:00 p.m. on May 22, 2021.
- To enter a bid in the silent auction, please register with GiveSmart utilizing your mobile device by texting BASHBCC to 76278.
- Once registered, you may access auction items through the "Items" tab.
- Auction bids must meet the minimum bid and minimum raise listed.
- Bidders will receive outbid text message alerts on their mobile device.
- Guests are responsible for all purchases made through GiveSmart.
- All sales are 'as is' and final. No exchanges or refunds will be made. No sales tax will be charged.
- All items must be paid for in full by credit card on May 22, 2021.
- Unless otherwise stated, all date-specific experiences will be scheduled in advance at a mutually agreed upon date and time.
- Unless otherwise stated or negotiated, all services and certificates are subject to availability and must be redeemed by May 28, 2022.
- All packages are subject to COVID-19 guidelines, rules, and restrictions.
- All donated packages are for the sole purpose intended. No commercial use or requests for additional services are proper or allowed.

Auction Check-out Procedures

- Auction check-out will occur following the event, and your credit card on file will be processed on May 22, 2021.
- Items such as gift cards or certificates will be mailed or emailed to the auction purchaser's address or email address on file in GiveSmart within 30 days of the event at no additional cost to the recipient.
- All tangible items must be picked up at one of our Red Cross office locations (Sacramento, Yuba City, Chico, Redding) by 7:00 p.m. on May 28, 2021.
 - Items will be available for pick up at the Sacramento Red Cross (1565 Exposition Blvd) on Thursday, May 27 (11-2; 4-7) and Friday, May 28 (11-2; 4-7)
 - All other locations will be by appointment only.
- Auction pickup will be contact-free through use of your vehicle's trunk. COVID-19 guidelines will be enforced.
- Items can be shipped for an additional, at-cost expense if requested. Your credit card on file will be charged if you request that your items be shipped.
- Any items not picked up by 7:00 p.m. on Friday, May 28, 2021 will be shipped at the purchaser's expense.
- Please note that alcoholic beverages cannot be shipped and must be picked up.
- Items can only be shipped to U.S. addresses.
