





## Our Strategic Plan Update



As we enter the final 6 months of our current Strategic Plan (June 30, 2020), we are encouraged by the positive momentum and movement of our extraordinary members.

The current Tiffany Circle strategic plan includes five goals for achievement by 2020:

1. Grow membership to **1,000 women**:
  - At 972 members, we are well on our way to 1,000 members. We began the plan with 809 members and have seen a tremendous growth.
2. Expand the number of Tiffany Circle regions to **55**:
  - With territory realignment, we will continue working toward our goal of having Tiffany Circle members in each of the organization's 50 regions in 2020.
3. Retain **90 percent** of members year to year:
  - With the average retention in women's giving circles being in the 45% range, our current retention rates embody the genuine dedication of our members.
4. Increase cumulative direct donations to **\$110 million**:  
*Achieved January 4, 2019*
  - In year one of our plan, we met and surpassed our direct donations goal of \$110 million, and at year-end reached \$120,115,429 in cumulative giving.
5. Have **250 members** record and track their hours for collective impact :
  - Volunteerism is critical to fulfilling our mission, and we know many of our sisters are hard at work in their local chapters and beyond. We have 112 women actively recording. We encourage all women to ensure their great volunteer work is recognized in our Volunteer Connection platform.

The Tiffany Circle National Council is currently developing new goals associated with our next three-year Strategic Plan, which will align with Red Cross organizational priorities and will be presented to the membership in May 2020.


## Volunteer Connection: Are You Recording Your Volunteer Hours?

What is Volunteer Connection? Volunteer Connection is an organization-wide volunteer management system used to engage, match, train and deploy volunteers in order to respond to community needs and advance the Red Cross mission. For every-one hour recorded in Volunteer Connection is equivalent to a \$25 donation to the American Red Cross. One of the main ways we quantify and communicate the value of volunteer contributions is through the story of volunteer hours. When you attend an American Red Cross meeting, a Tiffany Circle planning meeting or event, volunteer your time at a shelter or in the Chapter or participate in local smoke alarm installation, you are making a difference and we want to make sure you are recognized for your time. 
