Both men, who are not only faculty members but also Red Cross Instructors and members of the school's emergency response team, sprang into action. After sprinting to the locker room, they worked alongside two school nurses in performing one round of CPR and utilizing the AED until the student's heartbeat returned. #### Grandson Coached Through CPR When Grandmother Has Cardiac Arrest in the Cascades Region

Last year, 16-year-old Tayen Landers got in the car with his grandmother on his way home from school. He became concerned

as his grandmother seemed to lose control and began swerving. In an amazing display of bravery and action, Tayen unbuckled his seat belt and put his foot on the brake, stopping the car. He then pulled his grandmother out and called 911. The 911 operator talked him through how to perform CPR until EMS arrived. Tayen's grandmother eventually regained consciousness while her grandson kept saying, urgently, "Stay with me Gram. Stay with me." Officer Moon used his training to help save the life of an elderly woman who was found unconscious, without a pulse and not breathing at her residence. When he arrived on the scene, he quickly began CPR and continued until EMS arrived
